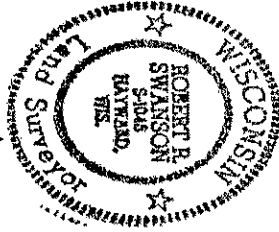


CERTIFIED SURVEY MAP

 S. LINE SEC.

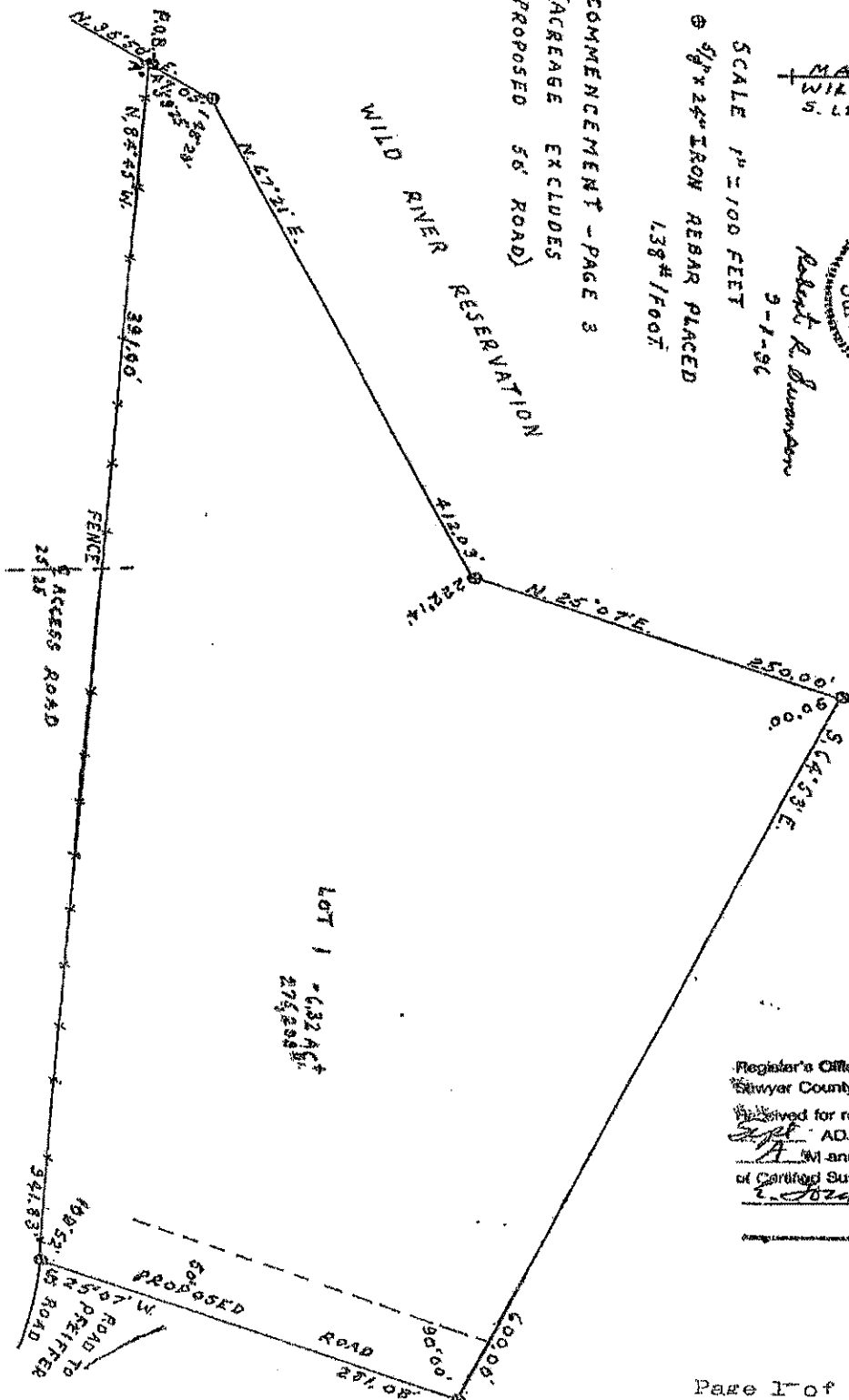

Legal Description of Lot 1

I, Robert R. Swanson, Wisconsin Registered Land Surveyor, do hereby certify under the provisions of Chapter 236.34 of the Wisconsin Statutes, and under the direction of Robert Sr. and Fern Sabin, owners of said land, I have surveyed, divided, and mapped the land herein described, and that said land lies in the southwest one-quarter of the southeast one-quarter (S.W. $\frac{1}{4}$ of S.E. $\frac{1}{4}$) of Section twenty (20), Township forty-two (42) North, Range eight (8) West, Town of Lenroot, Sawyer County, Wisconsin described as follows:

Commencing at the southwest corner of Section 20-42-8: thence South $88^{\circ}19'$ East along the south line of the Section 2596.89 feet to an iron rebar: thence North $1^{\circ}46'$ East 144.33 feet to an iron rebar: thence North $35^{\circ}50'$ East 506.40 feet to an iron rebar which is the point-of-beginning (point "A").

Thence North $35^{\circ}50'$ East 47.05 feet to an iron rebar:

Thence North $67^{\circ}21'$ East 412.03 feet to an iron rebar:

Thence North $25^{\circ}07'$ East 250.00 feet to an iron rebar:

Thence South $64^{\circ}53'$ East 600.00 feet to an iron rebar:

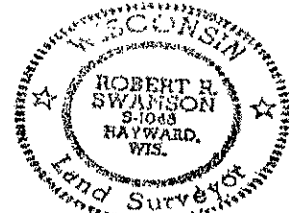
Thence South $25^{\circ}07'$ West 281.08 feet to an iron rebar:

Thence North $84^{\circ}45'$ West 941.83 feet to the iron rebar which is the point-of-beginning.

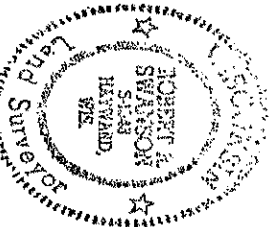

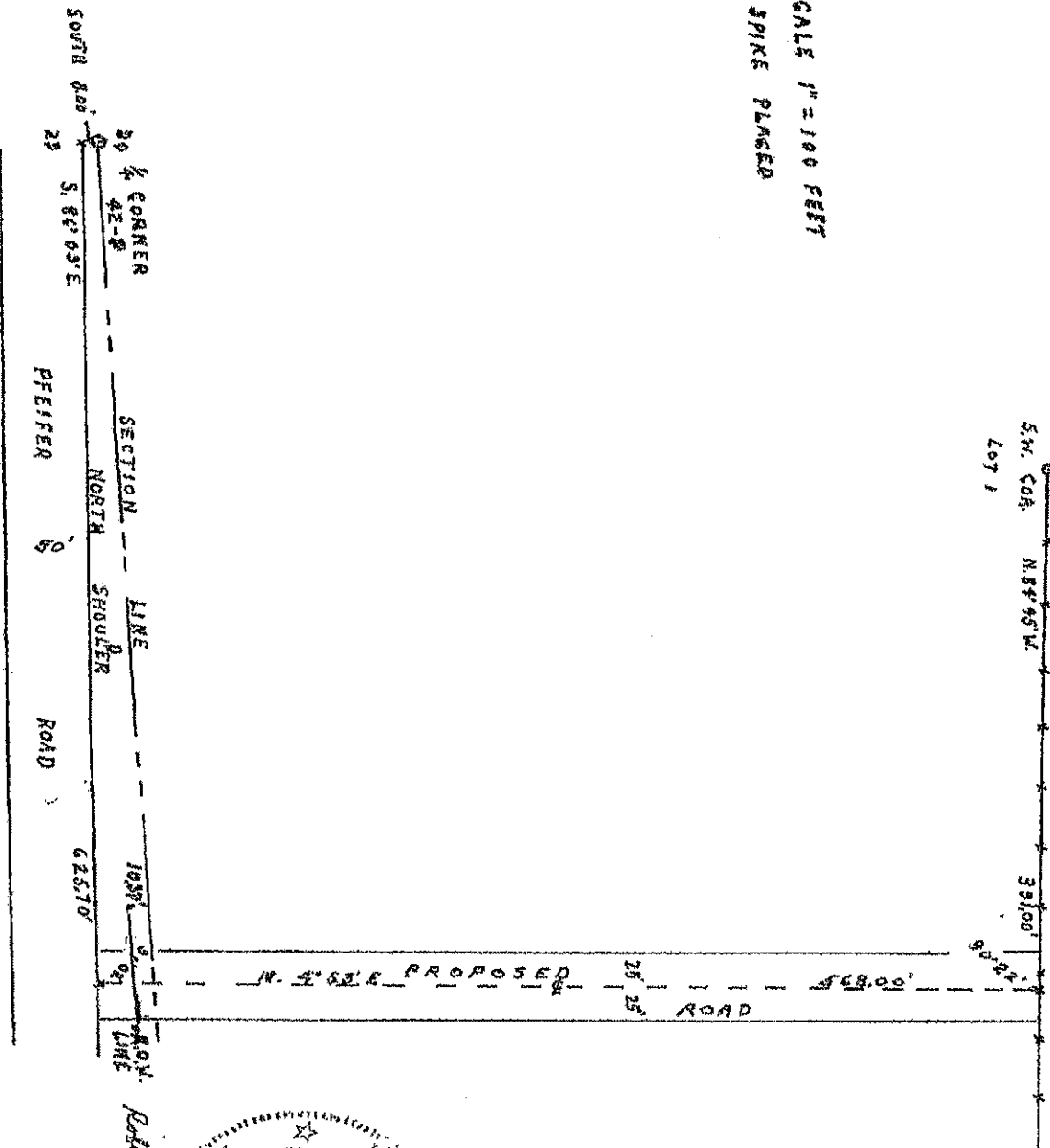
