

THE ORDINARY HIGH WATER LINE (OHWL) OF LITTLE ROSA LAKE IS APPROXIMATE AND FOR REFERENCE PURPOSES ONLY.

ANY LAND BELOW THE ORDINARY HIGH WATER LINE OF A LAKE OR A NAVIGABLE STREAM IS SUBJECT TO THE PUBLIC TRUST IN NAVIGABLE WATERS THAT IS ESTABLISHED UNDER ARTICLE IX, SECTION 1 OF THE STATE CONSTITUTION.

NO NEW LOTS ARE BEING CREATED BY THIS CSM. THE INTENT OF THIS CSM IS TO CLARIFY EXISTING LOT LINES AND ELIMINATE ENCROACHMENTS.

CSM NUMBERS 190, 191 AND 192 WERE PREPARED BY R. GORDON, PLS NO. 1146 AND WERE RECORDED ON AUGUST 8, 1977. THE FOUND 1" IRON PIPES NEAR LITTLE ROSA LAKE DO NOT MATCH THE RECORDED DATA AS SHOWN ON SAID CSM'S. THE RECORDED LOCATIONS FOR THE LOT CORNERS WOULD FALL IN LITTLE ROSA LAKE AND IT APPEARS AN ERROR WAS MADE WHEN THE LOTS WERE ORIGINALLY MONUMENTED. I HAVE ACCEPTED THE FOUND IRON PIPES AS PROPERTY CORNERS BASED ON THE LONGEVITY OF THE MONUMENTS AND APPARENT ACQUIESCENCE BY PROPERTY OWNERS.


